Just left a voice mail for you.

Let me know your comfort level with this; so we can follow up in a letter format.

Here is our scope and estimate without leak detection services.

Task 1: Review Facility Record Drawings and Available Data – Effort used to understand how the system works and identify all the key elements. (4 hours at \$180/hr = \$720)

Task 2: Site Visit and Discussion with Operations Staff – Upon review of available data and record drawings we can set up a site visit to meet and discuss with operations staff what has been observed and physically see the ponds and all key elements of the system. (3 hours at \$180/hr = \$540).

Task 3 and 4: Leak Detection Services Contractor Coordinate and Analyze LLSI Subcontractor Results: NV5 will facilitate contract and review the data received from the Leak Location Services Inc. (4 hours at \$180/hr = \$720)

Task 5: Prepare and Submit a Draft Technical Report summarizing the findings and recommendations. (18 hours at \$180/hr - \$2,880, 24 hours at \$110/hr - \$2,640, and 4 hours at \$96/hr - \$384) Total - \$6,664.

Task 6: Meeting with Client to Receive Comments on Draft Technical Report (4 hours at \$180/hr = \$720).

Task 7: Submit Final Technical Report with Suggested Corrective Action: (4 hours at \$180/hr - \$360, 10 hours at \$110/hr - \$1,100, and 2 hours a \$96/hr - \$192) Total = \$2,012.

Total Estimated NV5 Fee: \$11,000 (excluding leak detection services)...

Leak Location Service Inc. (LLSI) Estimate is \$10,500 for the two acre pond area (3 ponds). They prefer doing the survey when the ponds are full.
